- **BAOT/COT Professional Member** - To be eligible for this membership you should be a registered BAOT/COT member. This includes full and part-time members.
You must quote your BAOT number to receive membership at this price.
- **BAOT/COT Student Member**- This category includes all students who are undergoing a course within the United Kingdom and approved by Council, leading to a recognised occupational therapy degree. **You must quote your BAOT number to receive membership at this price.**
- **BAOT/COT Associate Member** - (Technical Instructor, OT Assistant/Helper, classroom support assistants, personal carers, etc.)This category is for members who are not eligible for HPC registration but are supervised by an occupational therapist that is eligible for professional membership. **You must quote your BAOT number to receive membership at this price.**
- **Overseas Membership** - This is for Occupational Therapists who are not resident within the UK and are NOT registered with BAOT or are BAOT-registered and request receipt of newsletters, etc by post rather than email.
- **Non-BAOT (renewal only)** - This category is for any current member resident in the UK who is not a BAOT/COT member and is renewing membership of COT-SS-PLD.
